**Enrollment Contract for 2017-2018**

THIS AGREEMENT made this \_\_\_\_\_ day of \_\_\_\_\_, 2017, by and between St. Patrick School / (the "School")

and \_\_\_\_\_ (singly/collectively called "Parent") in Miami Beach, Dade County, Florida:

Whereas, Parent desires to enroll the child (or children) named below as parts of the School's student body for the academic year 2016-2017, and intends by signing the Agreement to cause the School to reserve a place (or places) for their child (or children):

**NOW THEREFORE**, the School and Parent, hereby acknowledges, mutually covenant, and agree as follows;

1. **Non-refundable Registration Fee.** Parents shall pay to the School on the day of registration, non-refundable registration fee in the amount of \$400.00.
2. **Tuition:** Upon enrollment, Parent shall be obligated and legally responsible for payment of the full year's tuition per child as set forth on the attached form (tuition fee schedule/letter). This obligation to pay is absolute, whether or not any child attends for the full school year or any part thereof and whether or not a child is dismissed for cause or violation of the school's policies. Provided, however, that the Parent may avoid this obligation by written notice actually received by the School on or before May 1, 2017.
3. **Policies Made Part of Agreement.** The School's Policies are annexed and made part of this Agreement. The School shall have the continuing right to amend and modify those Policies from time to time so long as those policies apply to all attending students, and any such amendments or modifications shall be binding from the and after the date of mailing or other method of delivery of any such changes to Parents.
4. **Student.** The School shall reserve a space for the following child or children to be enrolled at the indicated level:
5. **Where applicable,** all monies owed to St. Patrick School, from prior academic years shall be paid before May 1, 2017 or this enrollment contract becomes null and void, and your child may not hold a position in the current school year.
6. If any tuition payment is not made within 10 days of the due date, it will be considered "past due" and subject to a \$25.00 *late fee* added to the regular payment.
7. Any *check returned* for any reason, including "Insufficient Funds," must be replaced by cash, cashier check, money order, or credit card. There is a \$30.00 penalty assessed for all returned checks, in addition to the late fee set forth above.
8. *Personal checks* will not be accepted from any family that has had two (2) returned checks in one academic year, or has had two (2) past due payments. All future payments must be paid by cash, certified check or money order.
9. Any students whose *tuition payments are two months' past due* will be suspended and not permitted to attend school until the account is current. Tuition must be paid in full by the last day of school in order to keep the student's place for the following school year. Amounts not paid when due may be referred to a collection agent or our attorneys, and you will be responsible for all costs of collection incurred by St. Patrick School, including but not limited to attorney's fees and cost.
10. Parent further understand *that this is a legally binding obligation* for the payment of all tuition and fees. In the event that the School must take action to recover any unpaid balances, Parent understand that, in addition to the unpaid tuition and late fees, Parents shall also be responsible for all expenses and costs of collection incurred by the School, including but not limited to attorney's fees and costs and any court fees incurred. This Agreement shall be governed by the laws of the State of Florida. Parent irrevocably submits to the exclusive jurisdiction of the courts of the State of Florida sitting in Miami-Dade County, Florida in connection with any litigation arising under this Agreement.
